1 On February 23, 2006, plaintiffs filed a complaint against defendants for
2 copyright infringement. Defendants filed an Answer on May 24, 2006.

3 On August 8, 2007, the Court filed its "(1) Granting Plaintiffs' Ex Parte
4 Application; (2) Granting Plaintiffs' Request for Sanctions; (3) Denying
5 Defendants' Request for Attorney's Fees and Costs and (4) Cautioning
6 Defendants regarding Potential Non-monetary Consequences of Further
7 Violations of Discovery Obligations and Orders (hereinafter "the Order").

8 On August 22, 2007 Defendants filed an ex parte application for stay and a
9 Notice of Motion and Motion for Review of the August 8, 2007 Order.
10 Defendants represent that they gave to plaintiffs' counsel the notice required by
11 Local Rule 7-19.1.

12 Based on the representations set forth in the ex parte application, the Court
13 finds that, because of significant privacy rights at issue and attorney client
14 privilege issues, the good cause shown due to excuseable neglect, the lack of
15 prejudice to or objection by plaintiffs,
