Comes now the Plaintiff, Jonathan Lee Riches<sup>Ⓢ</sup>, Political prisoner illegally detained in the Bureau of Prisons, in pro-se, Moves this Honorable court to Issue a TRO temporary Restraining order against Defendants stopping my extradition to Pakistan in March 2012 because I will be tortured by the Defendants and the Pakistani Government. Defendants put a detainer on me through Interpol, and plan to fly me out of the U.S. on a secret CIA cargo C-130 plane to Karachi Pakistan in March 2012. Plaintiff seeks declaratory Injunctive relief Against defendants. Plaintiff is a United States citizen under the Uniform commercial code U.C.C. 1-308. Plaintiff prays for relief

This is a classic case of mistaken Identity. My name is Jonathan Lee Riches<sup>Ⓢ</sup>, A U.S. citizen born in Pennsylvania. I'm currently illegally incarcerated at FCI Williamsburg in Sutters S.C. I'm serving 125 months in Federal prison illegally which is violating my 6<sup>th</sup> amendment rights under Booker and Fun Fun. INS Put a detainer on me on July 10, 2007. Defendants plan to deport me to Pakistan on March 23rd, 2012. Defendants want to try and hang me in downtown Karachi Pakistan because they think I'm a Taliban tribal leader from Federally Administered Tribal Areas of N.W. Pakistan.

Pakistan has another wanted Jonathan Lee Riches<sup>©</sup> who is a international fugitive for making nuclear weapons with Pakistani Scientist A.Q Khan on March 10, 1998, and Riches selling nuclear hardware to Libya, Iran, and North Korea. Jonathan Lee Riches is wanted by President Musharraf's military for money laundering Pakistani funds belonging to Shaukat Aziz Pakistan's prime minister through a identity theft ponzi scam into swiss bank accounts belonging to the Estate of former Enron CEO Kenneth Lay, Augusto Pinochet, and Filipino President Marcos. Bhutto will seek revenge on me for this attack, even though I'm not the same Jonathan Lee Riches. I will submit DNA. Plaintiff prays for relief.
